President Morgan thanked everyone who was involved in these proceedings, which have been a very long, but important process. As the proceedings continue tonight with a vote, it is the Board's hope that everyone in attendance remains respectful and mindful of others no matter what your personal viewpoint might be on this particular subject.

Attorney Zator went over logistics of meeting at this time, before moving to a vote. The only thing that will be occurring this evening with respect to the conditional use hearing is a vote by the Board of Commissioners.

A MOTION was made by Commissioner Wolk to deny approval of the Premier Center Luxury Apartments' Conditional Use. The motion was seconded by Commissioner Setton.

MOTON carried to deny conditional use for the Premier Center Luxury Apartments.

<u>Clarification of votes</u>:

Commissioner Wolk – The Applicant has not met the burden of proof required by the SWT Zoning Ordinance 350-18 for the granting of conditional uses. I vote YES to deny.

Commissioner Long – YES, to deny.

Commissioner Setton – YES, to deny. The last few months we have heard pros and cons regarding this development. We must understand that the landowner and/or the developer have the legal rights to develop their property consistent with the law. This property will some day be developed into something, and not everyone will agree with its concept. I believe most of us do want to see something different. Whatever is developed in this property, it is here to stay for many years to come. It is important to mention that what is good and safe to the Township is good and safe to the developer. I am not convinced that the traffic study introduced by the developer of this project was sufficient or accurate. Therefore, I vote YES (to deny).

Commissioner Kelly – I do not believe the developer met the burden of proof for conditional use for this property. I vote YES (to deny).

Commissioner Morgan – Based on the testimony provided during these proceedings, this has been a long and difficult decision to make. Based on the proceedings, I believe the traffic study was in fact insufficient. Therefore, my vote is also YES (to deny).

Solicitor Zator said this vote concludes the conditional use proceedings.
