#### **AGENDA ITEM #1 - CALL TO ORDER**

The meeting was called to order at 7:06 p.m.

### **AGENDA ITEM #2 - APPROVAL OF MINUTES**

The minutes of October 4, 2021 were approved as submitted.

#### **AGENDA ITEM #3 - OLD BUSINESS**

Chairman Yezerski opened nominations for the Nominating Committee to develop the slate of Commission Officers for the 2022 year.

Coordinator Kelly accepted the nomination to serve on the Nominating Committee.

#### AGENDA ITEM #4 - COURTESY OF THE FLOOR

Ms. Monica Hodges spoke concerning the intersection of Fairview Street and South 35<sup>th</sup> Street. The intersection has a stop sign provided for traffic on Fairview Street. Residents have reported that traffic frequently disregards the stop sign for Fairview Street.

Chief Dorney indicated that the Police will provide an increased patrol presence at this intersection. The installation of an additional stop sign for traffic on South 35<sup>th</sup> Street would require a traffic study.

An issue related to the intersection of Mauch Chunk Road and Overlook Road was discussed. This intersection is the site of frequent motor vehicle crashes, many of which being severe. Members inquired as to if the intersection can be provided with informational signage indicating that has a high rate of crashes.

Chief Dorney indicated that this is a PENNDOT intersection. He will check with Herb Bender from the Township Public Works Department to see what process could be used to establish the informational signage.

### **AGENDA ITEM #5 - NEW BUSINESS**

#### A. Commissioner's Report

None.

### **B. Fire Companies Report**

Chief Heicklen submitted the response report for Cetronia for the month of October 2021. It is included as an attachment to these minutes. Cetronia responded to fifty-six calls for the month of October 2021.

Chief Garger reported that Greenawalds responded to fifty calls for the month of October 2021.

Assistant Chief McCauley submitted the response report via for Tri-Clover for the month of October 2021 and year-to-date 2021. They are included as attachments to these minutes. Tri-Clover responded to twenty-six calls for the month of October 2021 and two-hundred and sixty-four calls year-to-date 2021.

The construction project for the Kernsville Road Bridge over the Jordan Creek is anticipated in 2022. This will result in the complete closure of the bridge to all traffic. Dispatch response boxes will be changed during this closure.

Chief Search submitted the response report for Woodlawn for the month of October 2021. It is included as an attachment to these minutes. Woodlawn responded to forty-eight calls for the month of October 2021.

### C. Fire Commissioner Report

Commissioner Kiskeravage reported that the dispatch response boxes for Tri-Clover have been submitted to Lehigh County Communication Center.

Assistant Chief McCauley indicated that an additional station is being dispatched between 6:00 am and 6:00 pm for single station responses. Other changes have yet to be implemented by the Communication Center.

#### D. Emergency Management Team Report

Coordinator Kelly reported that Pennsylvania House Bill 988 is currently in the comment phase. This legislation would repeal the current Commonwealth fireworks law.

The Limerick Generating Station drill is scheduled for November 16 & 17, 2021.

Cedarbrook personnel will be scheduling meetings with emergency services personnel to discuss access changes to the facility during the new construction project scheduled to start in 2022.

#### E. Police Report

Chief Dorney reported that the Police responded to one thousand, seventy-nine calls for the month of October 2021 and eleven-thousand, six-hundred and seventy-seven calls year-to-date 2021.

#### F. Emergency Medical Services Report

Mr. Frantz provided a report from Chief Executive Officer Mateff. Cetronia responded to three-hundred and eighty-five calls for the month of October 2021. Three of these calls were handled by a mutual aid provider.

Covid numbers continue to be low in the community. Cetronia co-hosted a flu vaccination clinic with Lehigh Valley Health Network for emergency responders and their families. According to the Network, this was the most successful of these types of clinics to date.

#### G. Subdivision Review

#### 1. Long's Water Technology Inc. - Major Plan 2021-106

Mr. Frantz indicated that a plan showing the fire apparatus turning detail was provided.

The Commission made no recommendations to the plan.

# 2. Proposed Commercial Development 1810 PA Route 309 – Major Plan 2020-103

Mr. Frantz indicated that the plan is to undergo a significant revision. Because of this, review of the current plan is not warranted.

#### 3. Ridge Farm FINAL PLAN 1A - Major Plan 2017-101

Mr. Frantz indicated that this plan represents the first phase of the complete Ridge Farm development plan.

The Commission reiterated its previous comment that the distance non-complaint right turn in/right turn out on Walbert Avenue between Office Center Road and North Cedar Crest Boulevard should be revised to be distance complaint or eliminated.




