AGENDA ITEM #1 - CALL TO ORDER

The meeting was called to order at 7:00 p.m.

AGENDA ITEM #2 - APPROVAL OF MINUTES

The minutes of November 1, 2021 were approved with a correction.

AGENDA ITEM #3 - OLD BUSINESS

A. Election of 2022 Officers

Coordinator Kelly and Mr. Kennedy nominated candidates Mr. Yezerski for Chairman and Mr. Snyder for Vice Chairman for consideration by the Board. Both passed by a unanimous vote from the members of the Board.

B. Other Items

Chairman Yezerski inquired about the status of the traffic concerns at the intersections of Fairview Street and South 35th Street, and Mauch Chunk Road and Overlook Road.

Sergeant Grozier indicated that he was unaware of the status of these issues.

Chairman Yezerski inquired about the status of the Tri-Clover fire response box assignments.

Assistant Chief McCauley indicated that the day time boxes have been implemented. The other changes have been submitted to but have not been implemented by the Lehigh County Communication Center. The boxes will also need to be temporarily modified when the construction activities commence on the Kernsville Road Bridge over the Jordan Creek. That project is expected to last four months.

Chairman Yezerski inquired as to if any meeting have been held between emergency services personnel and Cedarbrook personnel regarding access during construction activities.

Coordinator Kelly and Mr. Frantz indicted that construction activities have not commenced as of this date.

Chairman Yezerski inquired as to if future Commission meetings can be streamed via the Zoom Meeting platform.

Coordinator Kelly indicated that new Emergency Management laptop computers could be used to stream the meeting.

The members of the Commission unanimously agreed to stream future meetings via the Zoom platform, starting with the January 10, 2022 meeting. Mr. Frantz will contact management to arrange the streaming.

AGENDA ITEM #4 – COURTESY OF THE FLOOR

AGENDA ITEM #5 - NEW BUSINESS

A. Commissioner's Report

Commissioner Kelly inquired if there is a way for Township personnel to find and report inoperable street lights.

PPL Electric Utilities repairs public street lights in the Township. Information concerning the procedure to report inoperable street lights will be disseminated to the public via social media and/or a future Township newsletter.

B. Fire Companies Report

Chief Heicklen reported that Cetronia responded to fifty-four calls for the month of November 2021.

The fire departments had a busy month in November. Included in the calls was a fire on November 16 at a large house in Salisbury Township. Two firefighters from Cetronia became trapped inside and overrun by fire. Fortunately were able to escape the house through a second floor window. Both sustained serious injuries, one was hospitalized for two days while the other was hospitalized for four days. Cetronia extended its appreciation for all the agencies that supported them after that incident.

Cetronia has recently been dispatched to numerous EMS calls at the Warehouse at 5185 Crackersport Road. They have monitored the air quality at these calls but have found no issues. The fire department connection is currently blocked by fencing around portable toilets.

Mr. Frantz indicated that this was the first time that was made aware of the fire department connection issue. He will follow-up with the building owners.

Chief Garger submitted the response report via email for Greenawalds for the month of November 2021. It is included as an attachment to these minutes. Greenawalds responded to fifty calls for the month of November 2021.

It was observed at the Township tree lighting ceremony at Covered Bridge Park that logistical and operational challenges would have been present had there been an emergency at the event. Vehicle would have had a significant issue gaining access to the event. It would be beneficial if additional emergency services personnel could be involved in the planning of the event for 2022.

Coordinator Kelly indicated that an emergency plan for the event is required if the attendance exceeds three-thousand people.

Commissioner Kiskeravage indicated that discussions were held at the post-event meeting regarding the access issues.

Sergeant Grozier indicated that management is considering spacing out the activities over a greater time frame at next year's event as well as involving more individuals in planning meetings.

Assistant Chief McCauley submitted the response report via email for Tri-Clover for the month of November 2021 and year-to-date 2021. It is included as an attachment to these minutes. Tri-Clover responded to nineteen calls for the month of November 2021 and two-hundred and eighty-five calls year-to-date 2021.

Chief Search submitted the response report for Woodlawn for the month of November 2021. It is included as an attachment to these minutes. Woodlawn responded to fifty-three calls for the month of November 2021.

C. Fire Commissioner Report

Commissioner Kiskeravage reported that he and members from Woodlawn were travelling to South Dakota tomorrow for inspection of Woodlawn's new engine. It is anticipated that unit will be placed into service in January of 2022.

D. Emergency Management Team Report

Coordinator Kelly reported that the next Township Emergency Management meeting will be held at 7:00 pm on December 9, 2021 at the Joint Operations Center.

The Limerick Generating Station drill was held on November 16, 2021.

New laptop computers have been placed into service at the Township Emergency Operations Center.

E. Police Report

Officer Grozier reported that the Police responded to one thousand, twohundred and thirty-seven calls for the month of November 2021.

It is expected that an individual graduating from the Allentown Police Academy on Friday will be offered and accept employment with the Township.

There will be a graduation ceremony for the Township Citizens Police Academy on Thursday December 9, 2021 at the Township Building.

F. Emergency Medical Services Report

Chief Executive Officer Mateff reported that Cetronia responded to threehundred and ten calls for the month of November 2021. No calls were handled by mutual aid providers during the month.

There has been a small increase in Covid-related responses. All of Cetronia's personnel have been vaccinated.

G. Subdivision Review

1. Dorneyville Shopping Center Fast Casual Restaurant – Major Plan 2021-107

The Commission made no recommendations to the plan.

2. Proposed Commercial Development 1810 PA Route 309 – Major Plan 2020-103

Mr. Frantz indicated that the plan has been revised to remove the office building that had been proposed on the property as well as reduce the slopes of the driveways from PA Route 309 and Chapmans Road. Both driveways do not meet the separation distance requirements from intersections and will require approval from PENNDOT as well as the Township.

The Commission made the recommendation that the driveway separation distance requirements for both driveways comply with Township requirements.

3. Bortz Tract – Spring View Restaurant Land Development – Major Plan 2013-103

The Commission made no recommendations to the plan.

H. Address Assignments

1. 2787 PA Route 309

The Commission agreed with the recommendation from the Township Engineer of 2786 PA Route 309.

2. Ridge Farm 2017-101

Mr. Frantz indicated that the Township Engineer, South Whitehall Township Planner Gregg Adams, and he previously reviewed the street names against existing Township Street names. Eckert, Sheirer, Jonathan, William, Wehr, Blue Barn, Adams, and Guth were identified as being too similar to existing street names.

The Commission agreed with the address number assignments of the Township Engineer, but not aforementioned street names. The plan should be brought back to the Commission after a clean review by Township staff of the proposed names.






