Alarm Ordinance – Revised 2010

Reduce number of free occurrences from 3/6 months to 2/year

Invoice for occurrences quarterly vs bi – annually

Determine what conditions constitute a false alarm

Standardized reporting by each Fire Company and Police

Collections for unpaid invoices

Re-evaluate fees

Spill Response Ordinance – Revised 1997

Standardized reporting and materials used by each Fire Company

Check with Legal to see if costs can be submitted to insurance company for reimbursement -there is State Legislation that may address this.

Hotel/Motel Ordinance – New

Establish an inspection program for hotels/motels located in the Township

Currently there is no inspection program conducted by the State or County

Establish fees for initial inspection and any follow up inspections need to achieve compliance

Solid Waste and Recycling Ordinance – Revised 1985

Establish residential and commercial guidelines for the storage, placement and collection of solid waste and recycling, including yard waste and bulk items.

Address Household Hazardous Waste and electronics disposal

Vacant Property Registry Ordinance – New

Establish the for the registration of vacant properties via a third-party vendor

Establish registration fee for which a portion comes back to the Township

Establishes a data base of vacant properties located in the Township so that contact can be made to banks, etc to address maintenance issues at the property

Mobile Vending (Food Trucks) - New

Establish criteria for mobile vending units operating within the Township

Establish annual operational license fees
