#### **AGENDA ITEM #1 - CALL TO ORDER**

The meeting was called to order at 7:07 p.m.

#### **AGENDA ITEM #2 - APPROVAL OF MINUTES**

The minutes of January 10, 2022 were approved as submitted.

#### **AGENDA ITEM #3 - OLD BUSINESS**

## A. South 33<sup>rd</sup> Street & Fairview Street, Trexler Boulevard Traffic Issues

Sergeant Grozier reported that a speed display board will be placed in this area.

A speed display board had been put in place on Trexler Boulevard. 4.9% of the traffic exceeded the posted speed limit of 25 mph to the point where the excessive speed could have been enforced by the police.

A letter was sent from the Township Manager to PENNDOT requesting reconsideration of the right turn on red decision. It is included with these minutes.

#### AGENDA ITEM #4 – COURTESY OF THE FLOOR

The Board position formerly held by Mr. Kennedy was discussed. He had been serving as the Parkland School District representative in lieu of the District Superintendent. Mr. Kennedy will contact Superintendent Madson to discuss who will attend the Commission meetings as the School District representative.

Commissioner Kelly inquired about the recent numerous EMS responses to the warehouse at 5185 Crackersport Road and if the Township has any responsibility in reducing the number of future responses.

Commissioner Kiskeravage indicated that there have been nine EMS responses at the building since its completion. Of those nine responses, only three individuals have been transported to a medical facility. A recent response for twenty individuals that were not feeling well resulted in all individuals refusing to be treated by Cetronia Ambulance personnel at the scene. On the calls where the fire department has assisted EMS, air monitoring was performed with no atmospheric hazards identified.

Township personnel will meet with personnel from the facility to discuss if any actions can be taken to reduce the number of non-essential EMS calls from the facility.

Chief Heicklen reported that Cetronia responded to seventy calls for the month of January 2022.

Ricardo Diaz has been promoted to Deputy Chief 302, Thomas Williams to Assistant Chief 303.

Chief Garger submitted the response report via email for Greenawalds for the month of January 2022. It is included as an attachment to these minutes. Greenawalds responded to fifty-four calls for the month of January 2022.

Greenawalds responded to five fires and assisted eleven municipalities outside of the Township during January 2022.

Chief Neas submitted the response report via email for Tri-Clover for the month of January 2022. It is included as an attachment to these minutes. Tri-Clover responded to thirty calls for the month of January 2022. Tri-Clover representatives were absent from this meeting due to an active fire in North Whitehall Township.

Chief Search submitted the response report for Woodlawn for the month of January 2022. It is included as an attachment to these minutes. Woodlawn responded to sixty-five calls for the month of January 2022.

Sergeant Grozier reported that the Police responded to one thousand and sixty-three calls for the month of January 2022.

This letter is a request for PennDOT to reconsider a prior decision relating to Traffic Permit No. 39-103-008 in South Whitehall Township. The location of the proposed redevelopment is the southeast corner of the intersection of Cetronia Road (State owned) and Broadway (Township owned). The applicant, KRE Springview Commercial II, has requested a waiver form Township SALDO Section 312-36(c)(4)(B)(i) for driveway separation distance. The proposed driveway onto Broadway is less than 300' to the intersection of Broadway and Cetronia Road. The approval of this waiver was recommended by the Township Public Safety Commission (PSC) conditioned on the restriction of "no right turn on red" from northbound Cetronia Road to eastbound Broadway. PSC rational for recommending the condition is primarily since left turns would be permitted out of the driveway onto Broadway. The PSC feels this creates an unsafe condition. Therefore, the recommendation of a "no right on red" is a means to mitigate the potentially unsafe condition. This condition was previously rejected by PennDOT.

The condition recommended by the PSC is part of the approving resolution. Therefore, a modification to the resolution is required should PennDOT reject the request for a "no turn on red". The applicant appeared before the BOC at the December 15, 2021, meeting requesting an extension and the removal of the "no-right-turn on red condition" in the approving resolution. The BOC extended the approval for 90-days to allow for clarification of PennDOT's position on the "no-right-turn". This letter serves as a request for PennDOT to reconsider the "no-right on red" condition from northbound Cetronia Road to eastbound Broadway. Please reply to this letter prior to March 1, 2022.




