Manager Petrucci reported that the traffic analysis on Trexler Boulevard and Highland Street has been completed. The study indicated that Highland Street traffic would be affected by the installation of traffic calming measures on Trexler Boulevard.

A traffic calming policy is scheduled to be presented to the Board of Commissioners for their consideration at their May 17, 2023 meeting.

The residents of the Trexler Boulevard and Highland Street neighborhood will be sent invitations to attend the June 5, 2023 Public Safety Commission meeting. This will provide them with further updates and discussions concerning the installation of traffic calming measures on Trexler Boulevard and Highland Street.

B. Fire Companies Report

Chief Diaz reported that Cetronia responded to seventy-three calls for the month of April 2023. Included in these calls were five motor vehicle accidents with rescue and four building fires.

Chief Garger submitted the response reports via email for Greenawalds for the month of April 2023 and year-to-date 2023. They are included as attachments to these minutes. Greenawalds responded to sixty-seven calls for the month of April 2023 and two-hundred and twenty-eight calls year-to-date 2023. Included in these calls were four motor vehicle accidents with rescue, one rope rescue, and ten working fires.

Greenawalds held their annual Easter egg hunt in April.

Chief Neas submitted the response reports via email for Tri-Clover for the month of April 2023 and year-to-date 2023. They are included as attachments to these minutes. Chief Neas was not present at the meeting due to a training class. Mr. Frantz reported that Tri-Clover responded to thirty-two calls for the month of April 2023 and ninety-five calls year-to-date 2023.

Chief Search submitted the response report for Woodlawn for the month of April 2023. It is included as an attachment to these minutes. Woodlawn responded to eighty calls for the month of April 2023.

C. Fire Commissioner Report

D. Emergency Management Team Report

Coordinator Kelly reported that there will be a training session with Norfolk Southern on May 4, 2023 at 18:00 at Springhouse Middle School.

The annual emergency services meeting with Dorney Parks staff was held on April 19, 2023.

The presentation given by emergency management and Parkland School District personnel at the annual PSATS conference was so well received that they have been asked to give a similar presentation at a conference in October 2023.

E. Police Report

Sergeant Grozier reported that the Police responded to one thousand, two-hundred and seventy-one calls, had eighty-five reported crimes, and made thirty-six arrests for the month of April 2023.

F. Emergency Medical Services Report

Chief Executive Officer Mateff reported that Cetronia responded to twohundred and sixty-four calls for the month of April 2023. Three of those calls were handled my mutual aid providers.

He expressed appreciation to those that attended the annual Cetronia Gala event.

G. Parkland School District Report

Dr. Naradko reported that the district budget seminar was held in April 2023.

There will be a town hall meeting regarding feasibility planning for the district at the Orefield Middle School.

Upcoming events include the spring concert series, high school prom, the Festival of the Arts, and high school graduation.

The topic of traffic safety on U.S. Route 22 was discussed at the April 3, 2023 Public Safety Commission (PSC) meeting. The number and severity of crashes on Route 22 has increased in recent years. These incidents not only affect traffic on Route 22, but also township roads due to detouring traffic off of Route 22 in response to closures of Route 22 during the incidents.

It has been noticed that enforcement of aggressive driving on Route 22 seems to be non-existent. It is understood that the Pennsylvania State Police have many issues to attend to away from Route 22 enforcement, but this has left an enforcement gap that seems to be exploited by aggressive drivers.

The issues described above are not just specific to the portions of Route 22 within the township boundaries, but also the neighboring Lehigh County municipalities. The PSC believes that a multi-municipality effort to address the issues on Route 22 would be better than single efforts by each municipality.

The PSC makes the recommendation to the Board of Commissioners that the township contacts neighboring municipalities about initiating a combined effort to open dialogs with the Pennsylvania Department of Transportation and the Pennsylvania State Police concerning enforcement of aggressive driving on Route 22.
