

SECOND QUARTER PUBLIC WORKS PERMIT APPLICATIONS



Review of the first half of 2023 Financial Statements:

Overall Revenue percentages by Fund:

- **General Fund = 75.5 %**
- Fire Fund = 79.1%
- Water Fund = 50.1%
- Sewer Fund = 51.6 %
- Refuse = 52.6%

As you can see, we are on track or pacing ahead in all major funds for Revenue collection.

To highlight a few items in the General Fund:

- Real Estate Tax Revenue = 93.4%
- Earned Income Tax Revenue = 61.7%
- Business Privilege Tax Revenue = 102.8%
- Local Services Tax Revenue = 51.8%

Overall Expense percentages by Fund:

- **General Fund = 41.4 %**
- Fire Fund = 67.7%
- Water Fund = 74.2%
- Sewer Fund = 76.7 %
- Refuse = 91.9%

(Please note that the Water, Sewer and Refund funds are tracking ahead due to some annual encumbrances for LCA bills and Hauler Fees.)

For this first time since implementation of the Fire Tax, the Fire Fund did not need to borrow funds from the General Fund in order to pay expenses in the first quarter due to getting the fund built up and in a saving mode for large purchases such as new apparatus in the future.

In closing, the Township is currently tracking to be on pace or ahead in all major funds and is on pace and tracking with expenses. Further proof that the 2023 budget has been a success.



Although we have become busier than ever, the men and women of Greenawalds have handled the increased responsibility in stride. While many of our counterparts in the region continue to struggle with declining membership, the roster at our firehouse remains strong! We have continued to recruit new members each month and are happy to report that our atrition rate remains remaably low. Using a dedicated committee to incentivie member participation through department events, awards, and nominal stipends, we strive to put our members first and continually acknowledge the wonderful work they do in our community.

In addition to emergency incident responses, we have also had a busy quarter with events in and around our district. We have hosted several events at the firehouse including our annual Easter Egg Hunt, a workout, "Murph," honoring our fallen veterans on Memorial Day, and a pre-summer safety event and press conference in coordination with the LVHN Trauma Prevention Team and the Lehigh Valley DUI Task-Force. 





STAFFING AND RESPONSE TIMES

Staffing Program

Over the past several years we have started to transition away from the traditional home response model. Across the state, as indicated in the SR-6 report, the number of volunteer firefighters has fallen from over 300,000 to less than 50,000. We decided to modernize our approach to membership and responses to get ahead of this curve. We instituted a voluntary staffing program along with recruiting new members from outside our "first due." This has resulted in a large expansion of our roster giving us more flexibility with members' time as well as a firehouse that is nearly staffed 24/7/365. This has resulted in rapid turn-out times which have had a direct impact on lives saved and property conserved. While the average Turnout Time across the county are greater than 5 minutes, we have driven ours down to less than 1 minute.

call quickly, but on larger incidents they will need to be reinforced by additional personnel. For this reason, home response still remains important. With this new strategy, in the amount of time it used to take to get one piece of apparatus on the road, we are now getting our second and third units out the door with full crews as well. While many departments across the region struggle to get one staffed rig on the road, we enjoy the luxury of several with qualified personnel. On average, we have 11.25 members responding per call across all incident types! In Q2, 2023 members made 2,005 individual responses!





SIGNIFICANT RESPONSES

During the second quarter of 2023 Greenawalds responded to a number of significant incidents. On the rescue operations side of our house, we responded to several Motor Vehicle crashes requiring patient extrication including a Mass Casualty Incident on the PA Turnpike, a roll-over accident on Lincoln Avenue, and a very heavy entrapment involving a tractor trailer and a delivery truck on Rt. 22. We also made a special response to the Emergency Room at Lehigh Valley - Cedar Crest to assist the staff with the removal of a large bolt from a child's finger. On the fire side, Greenawalds responded in a number of different capacities to a large row home fire in the City of Easton on Memorial Day, two large apartment building fires in the Borough of Emmaus and Allen Township, as well a number of other house fires in the Township and around the county. Some photos of these events are below.













TRAINING PROGRAM

New Members

Every new member that comes into the department off the street, regardless of previous experience, goes through a rigorous Probationary Member Training program and assessment. They will also be sent to Firefighter 1 School to earn their basic firefighting credentials. This process



can take anywhere from a few months to a year based on previous experience and capabilities.









Advanced Training

After their initial training, our members move on to more advanced classes and skill sets over their years of service. This includes:



- Vehicle and Machinery Extrication
 - Emergency Medical Training
 - Hazardous Materials
- Rapid Intervention Teams (Firefighter Rescue)
- Technical Rescue (Rope, Collapse, Trench, C-Space)
 - Water Rescue
 - Active Assailant (Rescue Task Force)
- Greenawalds provides Vehicle Rescue Training to Every EMT, Paramedic and PHRN class in the Leigh Valley!
 - We also provide Training to the Parkland High School Science of Fire Class

TRAINING PROGRAM (CONTINUED)

Continuing Education

In the second quarter of 2023 Greenawalds hosted, several advanced and continuing education training opportunities for our members and our mutual aid partners including:

We also had two new members take their Essentials of Firefighting course outside of our firehouse, and several members completed their Emergency Medical Technician coursework.





- On June 14th, assessors from the Pennsylvania Law Enforcement Accreditation Commission conducted an on-site assessment of the Police Department. A physical assessment and file review assessment was conducted, and the assessors unanimously recommended that the South Whitehall Township Police Department be approved for Re-Accreditation at the Pa Chief's of Police Conference on July 25th.
