AGENDA ITEM #1 - CALL TO ORDER

The meeting was called to order at 7:02 p.m.

AGENDA ITEM #2 – ELECTION OF OFFICERS

The nominating committee offered Thomas Yezerski as a candidate for Chairman and Richard Snyder for Vice Chairman. Votes for both candidates passed unanimously.

AGENDA ITEM #3 - APPROVAL OF MINUTES

The minutes of December 4, 2023 were approved as submitted.

AGENDA ITEM #4 - OLD BUSINESS

Speed cushions have been installed on Trexler Boulevard along with the appropriate pavement markings and signage.

AGENDA ITEM #5 – COURTESY OF THE FLOOR

Sargent Grozier indicated that the Principal of the Cetronia Elementary School has inquired about the possibility of installing school zone traffic warning devices on Broadway in front of the school.

Director Bender indicated that the School District will need to first work with PENNDOT to obtain a permit from them to install the devices. They should contact the township after the PENNDOT permit is received.

AGENDA ITEM #6 - NEW BUSINESS

A. Commissioner's Report

None.

B. Fire Companies Report

Chief Diaz reported that Cetronia responded to fifty-two calls for the month of December 2023 and seven-hundred and fifty-one calls for the year 2023.

Chief Garger submitted the response report via email for Greenawalds for the month of December 2023 and the year 2023. They are included as attachments to these minutes. Greenawalds responded to fifty-nine calls for the month of December 2023 and seven-hundred and seventy-three calls for the year 2023. False and nuisance calls were down three percent in 2023.

Chief Neas submitted the response report via email for Tri-Clover for the month of December 2023 and for the year 2023. They are included as attachments to these minutes. Chief Neas was not present at the meeting due a conflicting training activity that he was attending.

Chief Search submitted the response report for Woodlawn for the month of December 2023. It is included as an attachment to these minutes. Woodlawn responded to sixth-eight calls for the month of December 2023 and eight-hundred and eighty-three calls for the year of 2023.

C. Fire Commissioner Report

None.

D. Emergency Management Team Report

Coordinator Kelly submitted the December 2023 Emergency Management Report. It is included as an attachment to these minutes.

South Whitehall provided the only municipal emergency management officials to attend the Lehigh County Healthcare Coalition Round Table. This round table is an attempt to get all healthcare providers in the county together to work with emergency management officials.

Manager Petrucci provided an update concerning personal care organizations operating in single-family dwellings and apartments. They are obligated under Commonwealth requirements to provide emergency plans for their operations. The township will add a checklist that will be used to identify these facilities when they renew their township Business Privilege License.

E. Police Report

Sergeant Grozier reported that the Police responded to one thousand and fifteen calls, had eighty reported crimes, and made thirty-five arrests for the month of December 2023.

Chief Dorney reported that six new officers are starting their field training period. Because of revisions to the Civil Service employment requirements, only three of these officers needed to be sent to academy training.

The No-Shave November Campaign collected \$3,270.00

F. Emergency Medical Services Report

Chief Executive Officer Mateff reported via email that Cetronia responded to three-hundred and forty-two calls for the month of December 2023. Five of those calls were handled by mutual aid providers. Additional information can be provided at the February meeting.

G. Parkland School District Report

H. Subdivision Review

1. 81 South Cedar Crest – Major Plan 2023-107

Mr. Frantz reported that this is a sketch plan for a development of eleven single-family detached houses. It is proposed to be served by township water and sewer.

The Commission requested that more detailed plans be submitted for review.

2. Lot Line Adjustment and Consolidation for Al-Ahad Islamic Center – Minor Plan 2023-204

The Commission made no recommendations to the plan.

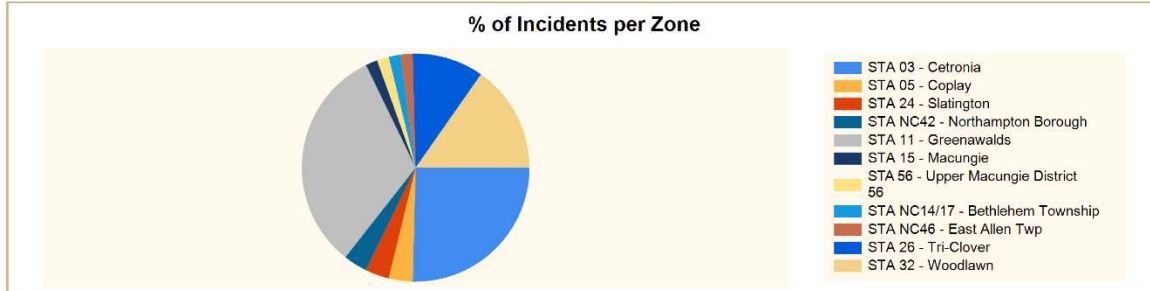

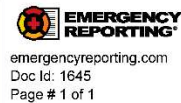

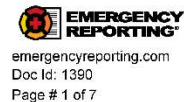
Count of Incidents by Incident Type per Zone

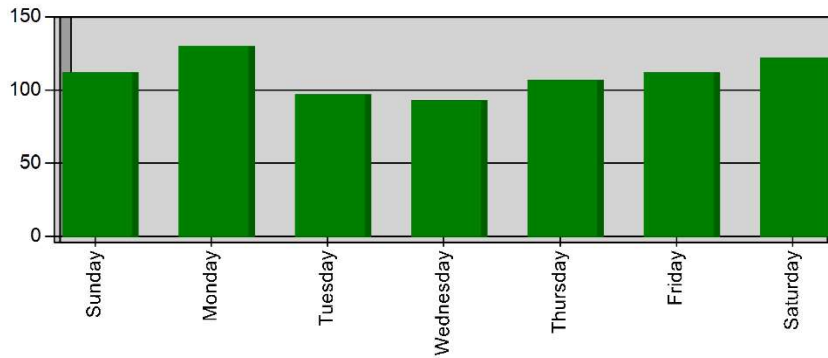
