The COVID-19 Small Business Grant Committee is pleased to recommend the following businesses as potential recipients of \$3500.00 each as part of the COVID Grant Program adopted by Ordinance 1055 on January 20, 2021.

In total, the Township received 39 applications. Of those 39 applications the Committee (made up of Township Finance Staff and Chamber staff) eliminated 31 of the applicants based on the adopted Ordinance. Reasonings for disqualification varied and included, incomplete paperwork, receipt of funding from other sources, less than a 20% decrease in revenues year over year and the business not being located in the Township. As a result, the Committee is pleased to present the attached list of businesses for consideration of \$3500 each in grant funding. Each of the listed businesses has submitted all appropriate paperwork and has met all criteria.
